DESCRIPTION OF DISASTER

The Federal Emergency Management Agency (FEMA) has declared a major disaster for the state of LOUISIANA opening the way for the use of federal disaster funds for people affected by *Hurricane Isaac* that occurred on August 26, 2012. Assistance is available to individuals and households in the following counties who may have experienced a loss due to this disaster:
